**How to determine School Board Support**  
 English-Public Anyone may support English-Public  
 English-Separate **This person** must be Roman Catholic  
 French-Public **This person** must have French-Language Education Rights  
 French-Separate **This person** must be Roman Catholic and have French-Language Education Rights

**French-Language Education Rights**  
 A person has French-Language Education Rights if they are a Canadian Citizen and can answer 'yes' to any one of the following:  
 1. Is French the language you first learned & still understand?  
 2. Did this person receive their elementary school instruction in Canada in French? (does not include French immersion or French as a second language)  
 3. Has any of this person's children received, or are any now receiving, elementary or secondary school instruction in Canada in French? (does not include French immersion or French as a second language)  
 (Note: as required by provincial legislation, school support is automatically defaulted to English-Public until the owner or tenant instructs otherwise)
