### Notice to the Municipal Electors of the Town of Petrolia

Town of Petrolia 2010 Municipal Election - Monday, October 25, 2010  
Nominations will be accepted from January 4 to September 10, 2010

Persons may be nominated as a candidate in the Municipal Election, for the positions set out below, by filing a nomination paper in person or by agent on the prescribed form, along with a \$100 filing fee for Council and School Board positions and a \$200.00 filing fee for the position of Mayor, anytime during office hours 8:30 a.m. to 4:30 p.m. beginning Monday, January 4<sup>th</sup>, 2010.

Photo identification must be provided upon filing and the fees for all offices are required payable in cash, certified cheque, or money order only.

On Nomination Day, Friday, September 10<sup>th</sup>, 2010, nomination papers may be filed anytime between 9:00 a.m. and 2:00 p.m.

The term of office is from December 1, 2010, to November 30<sup>th</sup>, 2014.

Nomination papers may be filed at the Office of the Clerk in Town Hall.

Nomination forms and full particulars of the nomination process can be obtained from the Office of the Clerk in which nomination papers must be filed, or telephone inquiries may be made to 519-882-2350.

No person who proposes to be a candidate may solicit or accept contributions for election purposes, or incur campaign expenses, until that person has filed a Nomination form with the Town Clerk.

### REQUIREMENTS FOR FILING NOMINATION PAPERS

1. The Nomination filing fee is **\$200** for Head of Council and **\$100** for all other offices payable by **Cash, Certified Cheque or Money Order only**. The filing fee is refundable if the candidate receives 2% of the vote.
2. All Candidates must provide Photo Identification.  
(A photocopy will be kept)
3. All Candidates must provide proof of Canadian Citizenship.  
(A photocopy will be kept)
4. Please ensure that the name on the form is the exact name you want to appear on the ballot, the name you are best known as is generally used.
5. The Certificate on the bottom of the nomination form can only be completed after the Voter's List has been checked to ensure that the candidate is an eligible voter. If your name does not appear on the Voter's List you will be notified.
6. The nominee or their agent will be asked to initial the date and time that the nomination paper is received and completed, therefore, nominations papers cannot be accepted by fax.
7. Nomination Papers are available to the public for viewing after filing.

#### Do Solemnly Declare That:

1. I am qualified pursuant to the Municipal Elections Act, 1996 and the Municipal Act, 2001 to be elected to and to hold the office of:  
 Mayor/County Councillor  Town Councillor
2. Without limited the generality of paragraph 1, on Voting Day, October 25, 2010, I will be at least eighteen years of age, am a Canadian citizen, a resident of the Town of Petrolia or the owner or tenant of land in the Town of Petrolia or the spouse or same sex partner of such owner or tenant.
3. I am not ineligible or disqualified under the *Municipal Elections Act, 1996*, the *Municipal Act, 2001*, the *Municipal Conflict of Interest Act* or any other Act to be elected to or hold the above-mentioned office.
4. Without limiting the generality of paragraph 3,
  - I am not an employee of the Town of Petrolia, or if I am an employee of the Town of Petrolia, I am on an unpaid leave of absence as provided for by section 30 of the *Municipal Elections Act, 1996*.
  - I am not a judge of any court.
  - I am not a member of the Assembly as provided in the *Legislative Assembly Act* or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the Town of Petrolia prior to 2:00 p.m. on Nomination Day, September 10, 2010. I understand that the Clerk of the Town of Petrolia will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.
  - I am not a member of the Executive Council of Ontario or a Federal Minister of the Crown.
  - I am not a Crown employee within the meaning of the *Public Service Act*, or if I am a Crown employee, I have followed and will continue to follow all the relevant provision of Part III of such *Act*.

5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996*.
6. Without limiting the generality of paragraph 5,
  - I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
  - I am not a person who was convicted of a corrupt practice described in subsection 90(3) of the *Municipal Elections Act, 1996*, during an election that occurred less than four years prior to Monday, October 25, 2010.
7. I am not a candidate who was convicted of a corrupt practice under the *Municipal Elections Act, 1996* or an offence under the Criminal Code (Canada), in connection with an act or omission with respect to a Municipal Election if the Voting Day in that election is less than six years prior to Monday, October 25, 2010.
8. I am not disqualified from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the *Municipal Elections Act, 1996*.

**AND** I make this solemn Declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath and by virtue of the *Canada Evidence Act*.
